- Adhere to the International Labor Organization's Declaration on Fundamental Principles and Rights at Work, including freedom of association and collective bargaining, nondiscrimination, the elimination of forced and compulsory labor, the abolition of child labor, and access to a safe and healthy working environment.
- Where applicable, commit to respecting Indigenous Peoples' rights in a way that honors their history, culture, and customs within legal and constitutional frameworks.

Chevron welcomes opportunities to collaborate with our business partners to build and sustain strong processes and systems for respecting human rights.
