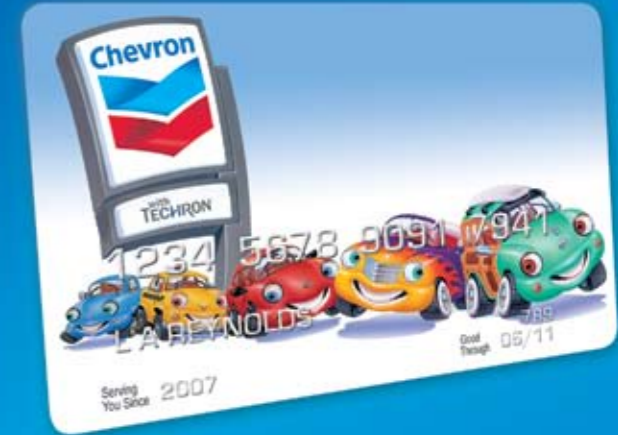
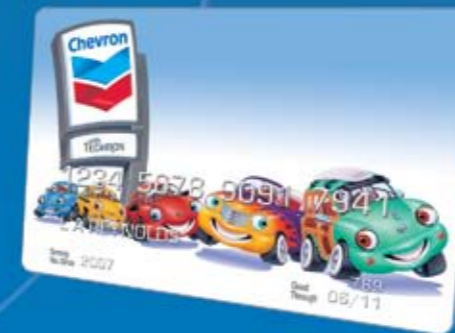

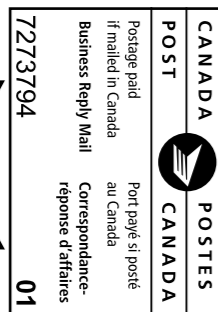

## 1. ACCOUNT AGREEMENT SUMMARY

### 1. Terms & Conditions:

To apply, you must:

1. Have reached the age of majority in your province/territory of residence;
2. Have not declared bankruptcy within the last seven years;
3. Be a permanent resident of Canada; and
4. Have a minimum annual income amount of \$15,000 and be currently employed.
